Commentary

The portfolio's return (net of all fees and expenses) for the month of September 2019 was -2.2%. The portfolio's Long investments detracted -0.9% from performance for the month of September 2019 and the Short portfolio, consisting of single stock Short positions, detracted -1.1% from performance during the month. The Australian Dollar appreciated slightly against the US Dollar during September, which detracted -0.2% from the return.
