NTA Update

Due to extreme market volatility, VGI Partners Asian Investments Limited (VG8) is providing an out-of-cycle update in the interests of ensuring a fully informed market.

As at 8.10am AEDT on 13 March 2020 (following US overnight equity and currency market close), the estimated net tangible asset backing per ordinary share for VGI Partners Asian Investments Limited (VG8) was \$2.60¹.

VG8 had net equity exposure of 30% and a cash weighting of 70%. Its net currency exposure was 96% USD and 4% JPY.
