### **Weekly NTA Update**

As at market close on 20 March 2020, the estimated net tangible asset backing per ordinary share for VGI Partners Asian Investments Limited (VG8) was \$2.80<sup>1</sup>.

VG8 had net equity exposure of 31% (long 37%, short -6%) and a cash weighting of 69%. Its net currency exposure was 85% USD, 10% JPY and 5% AUD.
