**Purchase of shares in VGI Partners Global Investments Limited (ASX:VG1)**

On 12 June 2020, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 23,101 shares in VG1 (the “Shares”) to hold on its own balance sheet.

Robert Luciano is a director of VG1 and also the majority shareholder in VGI Partners.
