**Purchase of shares in VGI Partners Global Investments Limited (ASX:VG1)**

On 22 July 2020, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 5,100 shares in VG1 (the “Shares”) to hold on its own balance sheet.
