**Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)**

On 17 July 2020, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 27,500 shares in VG8 (the “Shares”) to hold on its own balance sheet.
