**Purchase of shares in VGI Partners Global Investments Limited (ASX:VG1)**

On 17 December 2020, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 33,000 shares in VG1 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG1 to 3,880,303 ordinary shares.

Robert Luciano is a director of VG1 and also the majority shareholder in VGI Partners.

ASX Listing Rule 3.19A requires directors of listed companies to disclose details of shares in which they have a relevant interest. By virtue of being the majority shareholder in VGI Partners, Mr. Luciano has an indirect interest in any shares held by VGI Partners in VG1.
