**Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)**

On 18 December 2020, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 15,000 shares in VG8 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG8 to 11,184,732 ordinary shares.

Robert Luciano is a director of VG8 and also the majority shareholder in VGI Partners.

By virtue of being the majority shareholder in VGI Partners, Mr. Luciano has an indirect interest in any shares held by VGI Partners in VG8.
