Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)

On 21 December 2020, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 24,000 shares in VG8 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG8 to 11,208,732 ordinary shares.

Robert Luciano is a director of VG8 and also the majority shareholder in VGI Partners.
