**Purchase of shares in VGI Partners Global Investments Limited (ASX:VG1)**

On 18 January 2021, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 41,000 shares in VG1 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG1 to 4,409,748 ordinary shares.

Robert Luciano is a director of VG1 and also the majority shareholder in VGI Partners.

By virtue of being the majority shareholder in VGI Partners, Mr. Luciano has an indirect interest in any shares held by VGI Partners in VG1.
