**Purchase of shares in VGI Partners Global Investments Limited (ASX:VG1)**

On 15 February 2021, VGI Partners Limited (“VGI Partners”) (ASX:VGI) purchased 25,000 shares in VG1 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG1 to 5,440,829 ordinary shares.

Robert Luciano is a director of VG1 and also the majority shareholder in VGI Partners.
