**Purchase of shares to satisfy Dividend Reinvestment Plan**

VGI Partners Global Investments Limited (ASX:VG1) is pleased to provide an update in relation to the operation of its Dividend Reinvestment Plan (DRP).

Details of the DRP are set out in an announcement dated 23 January 2020.

In accordance with the DRP, VG1 has instructed a broker to purchase shares on-market on behalf of eligible shareholders who are participating in the DRP. The first purchases were made on 17 February 2021 following confirmation from the registry of the level of shareholder participation in the DRP.
