**Performance Fee Reinvestment Notice**

VGI Partners Asian Investments Limited (ASX: VG8) wishes to provide an update in relation to the operation of its Performance Fee Reinvestment Mechanism.

Details of the mechanism are set out in our announcement dated 23 February 2021. This announcement also states that the Performance Fee Reinvestment Amount for the period ended 31 December 2020 is \$3,608,391.

VG8 advises as follows:

- 120,000 VG8 shares were acquired on 18 March 2021 in relation to the Performance Fee Reinvestment Mechanism for total consideration (including brokerage) of \$283,761.
- In aggregate, 1,313,511 VG8 shares to a value of \$3,084,518 (including brokerage) have been acquired in relation to the Performance Fee Reinvestment Mechanism since 12 March 2021.
- The remaining Performance Fee Reinvestment Amount now stands at \$523,873.
