**Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)**

On 3 May 2021, VGI Partners Limited (ASX:VGI) purchased 25,000 shares in VG8 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG8 to 12,738,088 ordinary shares.

Robert Luciano is a director of VG8 and also the majority shareholder in VGI.

By virtue of being the majority shareholder in VGI, Mr. Luciano has an indirect interest in any shares held by VGI in VG8.
