As at market close on 4 June 2021, the estimated net tangible asset backing per ordinary share for VGI Partners Global Investments Limited (VG1) was \$2.63, after all applicable fees and charges.¹

VG1 had net equity exposure of 89% (long 106%, short 17%) and a cash weighting of 11%. Its net currency exposure was 100% AUD.
