**Weekly NTA Update**

As at market close on 4 June 2021, the estimated net tangible asset backing per ordinary share for VGI Partners Asian Investments Limited (VG8) was \$2.81, after all applicable fees and charges.<sup>1</sup>

VG8 had net equity exposure of 80% (long 84%, short 4%) and a cash weighting of 20%. Its net currency exposure was 100% AUD.
