**Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)**

On 28 June 2021, VGI Partners Limited (ASX:VGI) purchased 70,000 shares in VG8 (the “Shares”) to hold on its own balance sheet taking VGI’s total holding in VG8 to 13,908,640 ordinary shares.

Robert Luciano is a director of VG8 and also the majority shareholder in VGI.

ASX Listing Rule 3.19A requires directors of listed companies to disclose details of shares in which they have a relevant interest. By virtue of being the majority shareholder in VGI, Mr. Luciano has an indirect interest in any shares held by VGI in VG8.
