## 2021 Annual General Meeting

Dear Fellow Investor,

On behalf of the board of directors (**Board**) of VGI Partners Asian Investments Limited ACN 635 219 484 (**Company**), I am delighted to invite you to the 2021 annual general meeting (**AGM**) of the Company.

The AGM will be held online at <https://web.lumiagm.com/351413529> at 1:30pm (AEDT) on Tuesday, 16 November 2021. There will not be a physical venue for shareholders to attend. The Company is relying on the *Treasury Laws Amendments (2021 Measures No. 1) Act 2021* (Cth) to hold the virtual AGM, given the uncertainty and potential health risks associated with large gatherings during the COVID-19 pandemic.

Enclosed for your attention you will find:

- the notice of meeting (**Notice of Meeting**) and explanatory memorandum containing further information with respect to the business to be considered at the AGM (**Explanatory Memorandum**);
- a proxy form for the AGM (**Proxy Form**); and

The VG8 AGM will commence at 1:30pm (AEDT) with an address from me, the Chair. ### **Business to be considered at the AGM**

#### **Item 1: Consideration of financial statements and reports**

To receive and consider the annual report, financial statements, directors' report and auditor's report of the Company for the financial year ended 30 June 2021 (**FY21**).

***Please note that this item of business is for discussion only and there is no requirement for Shareholders to approve these reports.***

#### **Resolution 1: Adoption of the FY21 Remuneration Report**

To consider and, if thought fit, pass the following as a non-binding ordinary resolution:

*"That, for the purposes of section 250R(2) of the Corporations Act 2001 (Cth) and for all other purposes, the remuneration report of the Company as contained in the Company's annual report for the financial year ended 30 June 2021 be adopted."*

A voting exclusion statement for this resolution is set out on page 2 of this notice of AGM (**Notice of Meeting**) and further information on this resolution is set out in the explanatory memorandum which accompanies and forms part of this Notice of Meeting (**Explanatory Memorandum**).

***Please note that the vote on this resolution is non-binding.***

#### **Resolution 2: Re-election of Mr. Lawrence Myers as a director of the Company**

To consider and, if thought fit, pass the following resolution as an ordinary resolution:

*"That Mr. Lawrence Myers, a Director who, pursuant to Clause 60.1 of the Company's Constitution, retires by rotation and offers himself for re-election, be re-elected as a Director of the Company."*

The Explanatory Memorandum sets out further information on this resolution.

## **Voting Exclusion Statement**

### **Resolution 1 (Remuneration Report)**

Pursuant to sections 250BD and 250R of the *Corporations Act 2001* (Cth) (**Corporations Act**), the Company will disregard any votes cast on Resolution 1:

- by or on behalf of a member of the Company's key management personnel (**KMP**) whose remuneration details are included in the Company's remuneration report for the financial year ended 30 June 2021 (**Remuneration Report**) or their closely related parties, regardless of the capacity in which the vote is cast; or
- as a proxy by a person who is a member of the Company's KMP at the date of the AGM or their closely related parties,

unless the vote is cast as a proxy for a person entitled to vote on Resolution 1:

- in accordance with a direction in the proxy form (**Proxy Form**); or
- by the Chair of the AGM, provided the proxy appointment expressly authorises the Chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the Company's KMP.

## **Voting Information**

Pursuant to clause 40.2(c) of the Company's Constitution, and section 250J(1) of the Corporations Act (as amended by the *Treasury Laws Amendments (2021 Measures No.1) Act 2021* (Cth)) , the Chair will put all resolutions to a poll. Results of the voting on the resolutions will be announced to the ASX as soon as practicable after the AGM.

### **Entitlement to vote**

In accordance with section 1074E(2)(g)(i) of the Corporations Act and regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), the Company has determined that for the purpose of the AGM, all shares in the capital of the Company will be taken to be held by the persons who held them as registered holders at 7:00pm (AEDT) on Sunday 14 November 2021. Accordingly, share transfers registered after that time will be disregarded in determining entitlements to attend and vote at the virtual AGM.

### **Proxies**

A Shareholder entitled to attend and vote at the virtual AGM is entitled to appoint not more than two proxies to attend and vote in their place. A proxy does not need to be a Shareholder. If a Shareholder appoints two proxies, the Shareholder may specify the proportion or number of votes each proxy is entitled to exercise. If no proportion or number of votes is specified, each proxy may exercise half of the Shareholder's votes. If the specified proportion or number of votes exceeds that which the Shareholder is entitled to, each proxy may exercise half of the Shareholder's votes. Any fractions of votes brought about by the apportionment of votes to a proxy will be disregarded.

## **Explanatory Memorandum**

This Explanatory Memorandum provides Shareholders with important information in relation to each item of business for the AGM, including the proposed resolutions to be considered by Shareholders of the Company.

Terms and abbreviations defined in the Notice of Meeting have the same meaning when used in this Explanatory Memorandum.

### **Financial statements and reports (not voted on)**

The business of the AGM will include the receipt and consideration of the Company's annual report, financial statements, directors' report and the auditor's report for the financial period ended 30 June 2021 (**Reports**) as required by section 317 of the Corporations Act. The Reports are included in the Company's annual report, which was lodged with the ASX on 19 August 2021.

A copy of the annual report is available from the Company's website at [www.vgipartners.com/lics/vg8](http://www.vgipartners.com/lics/vg8).

Neither the Corporations Act, nor the Company's Constitution, require a vote of Shareholders on the Reports. However, Shareholders will be given a reasonable opportunity to ask questions and make comments in relation to both the Reports and the business and management of the Company.

Shareholders will also be given a reasonable opportunity to ask questions of a representative of the Company's auditor, Pitcher Partners, relevant to the conduct of the audit, the preparation and content of the Company's financial statements and auditor's report, the accounting policies adopted by the Company in relation to the preparation of the financial statements and the independence of the auditor in relation to the conduct of the audit.

### **Resolution 1: Adoption of the FY21 Remuneration Report (non-binding resolution)**

Resolution 1 provides Shareholders the opportunity to vote on the Company's Remuneration Report. Under section 250R(2) of the Corporations Act, the Company must put the adoption of the Remuneration Report to a vote at its AGM. The Remuneration Report forms part of the directors' report and is set out in the Company's annual report for the financial year ended 30 June 2021 on pages 13 to 14.

The Remuneration Report describes the policies of the board of directors of the Company (**Board**) in relation to the nature and level of remuneration paid to the Company's directors. Messrs. Robert Luciano and David Jones are directors of VGI Partners Limited, the parent company of the investment manager of the Company's investment portfolio, and do not receive directors' fees directly from the Company.

While the vote on the Remuneration Report is advisory only and does not bind the directors or the Company, the Board will take the outcome of the vote into account when considering the Company's future remuneration arrangements.

Additionally, under the Corporations Act, if 25% or more of the votes cast are against the adoption of the Remuneration Report at two consecutive annual general meetings, Shareholders will be required to vote at the second of those annual general meetings on a resolution (**Spill Resolution**) that another meeting be held within 90 days (**Spill Meeting**) at which all of the Company's directors, other than the managing director, will cease to hold office unless re-elected at the Spill Meeting. The Spill Resolution is an ordinary resolution.

Shareholders will be given a reasonable opportunity at the AGM to ask questions about, and make comments on, the Remuneration Report.

The voting exclusion statement for Resolution 1 is set out on page 2 of the Notice of Meeting.

*The Board unanimously recommends that Shareholders **vote in favour** of adopting the Remuneration Report.*

**Resolution 2: Re-election of Mr. Lawrence Myers as a director of the Company**

Clause 60.1 of the Company's Constitution provides that at the close of each annual general meeting, one-third of the Directors or, if their number is not a multiple of three, then the number nearest to but not more than one-third of the Directors, must retire by rotation.

Clause 60.2 of the Company's Constitution states that the Directors to retire in accordance with clause 60.1 must be those who have been longest in office since their last election.

Having regard to the above, Mr. Lawrence Myers has agreed to retire in accordance with clause 60 of the Company's Constitution, and being eligible, will stand for re-election as a director of the Company at the AGM.

Mr. Myers is also the CEO of FIFO Investments Pty Limited, the family office for the Myers family and a number of associated families.</p> <p>Mr. Myers' specialist areas of practice include mergers and acquisitions, corporate and business advisory, tax consulting and advisory, succession planning and family office services. Mr. Myers is also a member of the Foundation board of the Art Gallery of New South Wales.</p>
Time in office:	Mr. Myers was appointed as a director of the Company on 31 July 2019.
Independence:	Mr. Myers is considered by the Board to be an Independent Director of the Company.
Other current listed company directorships:	Mr. Myers has been an Independent Director and Chairman of the Audit and Risk Committee of ASX listed Breville Group Limited since 2013 and has been its Lead Independent Director since August 2014. Mr. Myers is also an Independent Director of VGI Partners Global Investments Limited.
Former listed company directorships (last three years):	Mr. Myers has not held any other directorships of listed companies within the last three years.

*The Board (excluding Mr. Lawrence Myers due to his conflict of interest) unanimously supports the re-election of Mr. Lawrence Myers and recommends that Shareholders **vote in favour** of Resolution 2.*
