As at market close on 15 April 2022, the estimated net tangible asset backing per ordinary share for VGI Partners Asian Investments Limited (VG8) was \$2.30 ex-dividend and after all applicable fees and charges.¹

VG8 had net equity exposure of 68% (long 83%, short 15%). Its net currency exposure was 100% AUD.
