Weekly NTA Update

As at market close on 17 June 2022, the estimated net tangible asset backing per ordinary share for VGI Partners Global Investments Limited (VG1) was \$1.87, after all applicable fees and charges.¹

VG1 had net equity exposure of 45% (long 94%, short 49%). Its net currency exposure was 100% AUD.
