Weekly NTA Update

As at market close on 5 August 2022, the estimated net tangible asset backing per ordinary share for VGI Partners Global Investments Limited (VG1) was \$1.93, after all applicable fees and charges.¹

VG1 had net equity exposure of 53% (long 99%, short 46%). Its net currency exposure was 100% AUD.
