### **Weekly NTA Update**

As at market close on 2 December 2022, the estimated net tangible asset backing per ordinary share for VGI Partners Global Investments Limited (VG1) was **\$1.73**, after all applicable fees and charges.<sup>1</sup>

VG1 had net equity exposure of 49% (long 93%, short 44%). Its net currency exposure was 100% AUD.
