**Weekly NTA Update**

As at market close on 3 February 2023, the estimated net tangible asset backing per ordinary share for VGI Partners Global Investments Limited (VG1) was **\$1.89**, after all applicable fees and charges.<sup>1</sup>

VG1 had net equity exposure of 69% (long 97%, short 28%). Its net currency exposure was 100% AUD.
