### **Weekly NTA Update**

As at market close on 17 February 2023, the estimated net tangible asset (NTA) backing per ordinary share for VGI Partners Global Investments Limited (VG1) was **\$1.89**, after all applicable fees and charges.<sup>1</sup>

The NTA of \$1.89 is inclusive of the recently announced interim dividend of 4.5c per share which has an ex-date of 23 February 2023 and is payable on 29 March 2023. VG1 is pleased to offer investors access to a Dividend Reinvestment Plan (DRP). Please note, elections are due by 5pm (AEDT) 27 February 2023 for those wishing to change from payment by EFT or cheque to the DRP.

As at 17 February, VG1 had net equity exposure of 73% (long 98%, short 25%). Its net currency exposure was fully hedged to AUD.
