Purchase of Shares to Satisfy Dividend Reinvestment Plan

Regal Asian Investments Limited (RG8) is pleased to provide an update in relation to the operation of its Dividend Reinvestment Plan (DRP).

Details of the DRP are set out in an announcement dated 21 July 2021.

RG8 has instructed a broker to purchase shares on-market on behalf of eligible shareholders who are participating in the DRP. The first purchases were made on 2 March 2023.

The DRP price will be the lesser of the average price of the RG8 shares acquired on-market and \$2.40, being RG8's NTA as announced to the ASX on 27 February 2023.
